Amendment to the ToR

Notice of Submission of an Amendment to the Terms of Reference

As part of the planning process for the Southwestern Landfill Proposal, Walker Environmental Group (WEG) is providing notice that an **Amendment to the Terms of Reference (ToR)** is being submitted to the Ministry of the Environment (the Ministry) for review as required under the *Environmental Assessment Act*. If approved, the ToR will serve as a framework for the preparation and review of the environmental assessment for the proposed undertaking.

The three page Amendment to the ToR is being submitted to the Ministry in response to comments received through the Ministry. The Amendment to the ToR provides clarifications and further commitments as to how WEG will conduct the Environmental Assessment for the proposed Southwestern Landfill. The Amendment includes topics such as:

- Enhanced considerations around the following:
 - Thames River basin scale
 - Wellhead Protection Areas (WHPA) associated with the Town of Ingersoll's municipal drinking water wells
 - Highly Vulnerable Aquifers (HVA)
 - Significant Groundwater Recharge Areas (SGRA)
 - Ongoing dewatering and rehabilitation by Carmeuse Lime (Canada) Ltd.
 - Noise emissions from major potential sources
 - Mapping of geological exposures in the existing quarry, borehole investigations and testing
 - Presence of Karst features within the bedrock in consultation with an expert in Karst geology
- Clarifications regarding consultation:
 - With interested parties when finalizing the technical work plans
 - With the County of Oxford to identify any existing plans for municipal well field expansion
- Sharing of data collected related to the Thames River with regulatory agencies
- Identification of any associated approval requirements in the EA

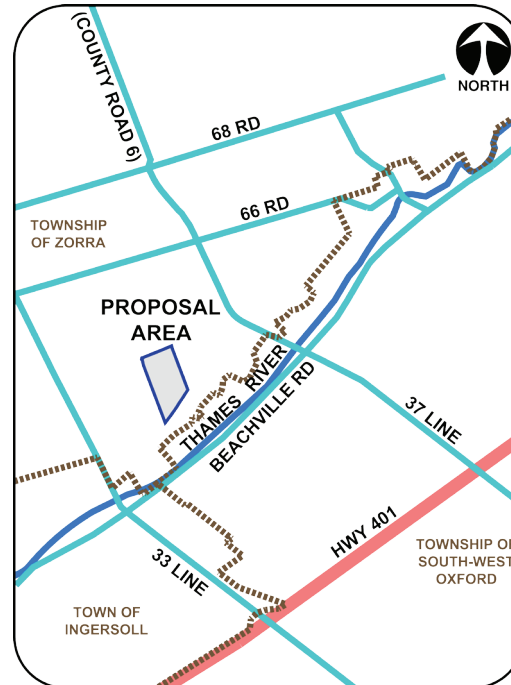
WEG is considering a Proposal that will grow its waste management business into Oxford County. The Southwestern Landfill Proposal seeks to develop a modern landfill in a mined quarry in Zorra Township – specifically, the Carmeuse Lime (Canada) Ltd. Beachville Operations located at 374681 37th Line (Oxford County Road 6), Zorra Township. If approved, the site will receive solid non-hazardous waste generated in the Province of Ontario. The proposed site will have an estimated total waste volume of about 17 million cubic metres over a planning period of about 20 years.

The **Amendment to the ToR**, update to the Record of Consultation and comment disposition tables will be available for viewing during normal business hours at the locations noted.

Please note that comments on the ToR Amendment are to be submitted to the Ministry of the Environment. The update to the Record of Consultation and comment disposition tables are being provided for information purposes only.
