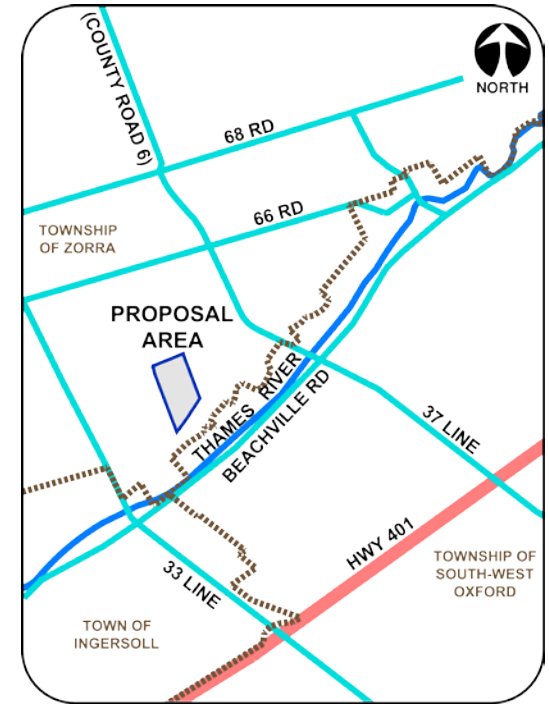
## Terms of Reference

### Notice of Submission of Terms of Reference

As part of the planning process for the Southwestern Landfill Proposal, Walker Environmental Group (WEG) is providing notice that the **Terms of Reference** will be submitted to the Ministry of the Environment for review as required under the *Environmental Assessment Act*. The Terms of Reference outlines the framework for the preparation and review of the Environmental Assessment for the proposed Southwestern Landfill.

WEG is considering a Proposal that will grow our waste management business into Oxford County. The Southwestern Landfill Proposal seeks to develop a modern landfill in a mined quarry in Zorra Township – specifically, the Carmeuse Lime (Canada) Ltd. Beachville Operations located at 374681 37th Line (Oxford County Road 6), Zorra Township. If approved, the site will receive solid non-hazardous waste generated in the Province of Ontario. The proposed site will have an estimated total waste volume of about 17 million cubic metres over a planning period of about 20 years. A landfill in this location could provide the cornerstone for the development of a ‘campus’ of environmental businesses in Oxford County supporting local and regional economic development.
