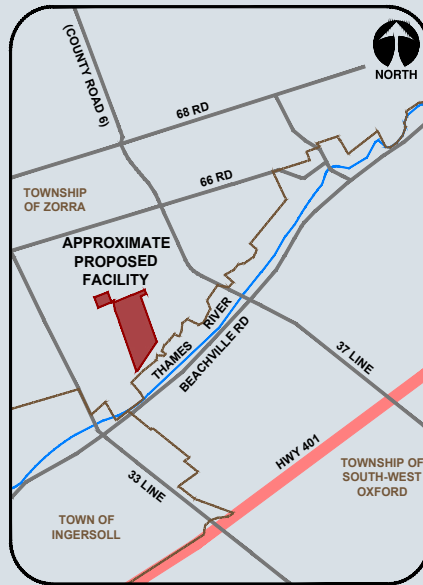


The Draft Environmental Assessment (EA) for the Walker Environmental (Walker) Southwestern Landfill Proposal will be available for review and input on March 2, 2020 for 15 weeks. Members of the public, agencies, and Indigenous communities are asked to provide comments on the Draft EA to Walker by June 15, 2020.

Walker has undertaken an EA for 17 million cubic metres of landfill capacity in the Township of Zorra. If approved, the site would accept only solid non-hazardous waste generated in Ontario.

This EA was carried out in accordance with the Approved Amended Terms of Reference and the requirements of the EA Act.
